

## New York Islanders “Custom Nickelodeon Goalie Mask” Sweepstakes

The following terms and conditions (collectively, the "Official Rules") shall apply to the New York Islanders “Custom Nickelodeon Goalie Mask” Sweepstakes ("Sweepstakes").
